Dental Services

The Tuscarawas County General Health District Dental Clinic provides its patients with affordable and necessary dental care. The Dental Clinic staff provides patients with both preventative and restorative dental services.

Family Planning Services

The Family Planning staff provides physical examinations, education and counseling to those men and women desiring the choice of when to begin a family and the spacing of their family. Family Planning education is also presented to schools and other groups that desire information.

Prenatal and Post-Partum Services

Prenatal care encourages expectant mothers to begin care for themselves and their unborn child as soon as possible. Post partum care insures proper follow up for the recovery of the mother. Consultative and educational sessions are presented on nutrition, medical assessment, child development, exercise and child safety. Child birth classes offered.

Women's Health Day

In conjunction with Women's Health Month the Health Department sets aside two days exclusively for screens and lab work.

Tuscarawas and Carroll Counties Alcohol and Addiction Center

The Alcohol and Addiction Center has shown a high degree of effectiveness. In addition to being certified by the Ohio Department of Alcohol and Drug Addiction Services, the program holds a facility certification from the Ohio Department of Mental Health. This designates our center as one that is qualified to treat the full range of chemical dependency disease. Our Counselors are also licensed to treat mental and emotional disorders.

Services

The Alcohol and Addiction Center views alcoholism and chemical dependency as major health problems. As with any disease, chemical dependency affects not only the individual, but the whole family. The Alcohol and Addiction Center's services include individual and group counseling, family counseling, consultation, referral, Antabuse therapy and a Family Insight Group. Since the agency is housed in a public health setting, medical as well as behavioral needs are met. Some of the highlights of our agency are as follows: Weekly group therapists called "Problem Dependency Clinic and Recovery Discussion Group" are held for our clients every Wednesday and are by referral only. An intensive outpatient program called "Family Insight Group" educates people on the effects of substance misuse. One of our significant projects, the Jail-Ender's Felon 432, has provided a community based treatment alternative to reduce the staggering costs associated with incarceration. The Governor's Office of Criminal Justice Services remains a primary funding source for our two county treatment and prevention activities.

Mission

The mission of the Alcohol and Addiction Center is to safely detoxify the individual via outpatient physician supervision or by referral to inpatient detoxification/rehabilitation services. Our philosophy is that chemical dependency is a primary disorder that must be treated first in order to apply other treatments for additional problems. The dependency must be placed in remission and then underlying medical or psychological conditions can be treated. Our counselors maintain a high degree of competency as evidenced by their affiliation with the Ohio Credentialing Board for Chemical Dependency Professionals and the Ohio Counselor and Social Worker Board. Currently there are two licensed and three certified individuals on staff.

Chemical Dependency Prevention and Education

Another very important service of the Alcohol and Addiction Center are prevention and educational programs. It is led by the only Ohio Certified Prevention Consultant in two counties. Goals include distributing information and presenting programs to area organizations and schools. Presentations are available in the areas of drug addiction, alcohol dependency, co-dependency and prevention, intervention or treatment concerns. The Alcohol and Addiction Center also conducts a D.U.I. Counterattack School that is a Certified Driver Intervention Program. This outpatient program is used for juveniles who are convicted of driving under the influence. The establishment of peer counseling program along with curriculum and school policy development marked this effective prevention program. Prevention activities save future treatment costs.

ENVIRONMENTAL HEALTH

In 1981 our Annual Report contained the following statement: "Environmental Health, as conceived by Moses and the ancient Greeks and Romans, dealt with gathering places and devices of living. It has not changed, only intensified."

The public perception of Environmental Health needs has resulted in many new and modified approaches during the past 10 years. Concerns about solid waste disposal, recycling, indoor air pollution, lead poisoning, and the chemical quality of our water supplies are some of the areas where new regulations demand a new approach to secure new answers.

The following statistical comparison of 1981 and 1991 environmental activities indicates many changes. The dramatic range from minus 100% in some areas to a plus 1200% in others reflects the adaptability necessary to provide modern environmental health services.

The fact that there is an overall increase of 36% in a decade of environmental activities confirms that "AS LONG AS WE HAVE MORE PEOPLE COMPETING FOR EXISTENCE AND SPACE ON THIS EARTH, WE WILL HAVE A GREATER NEED FOR ENVIRONMENTAL HEALTH SERVICES."

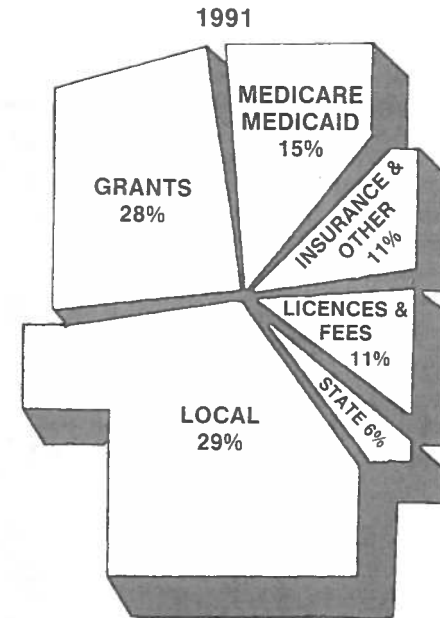
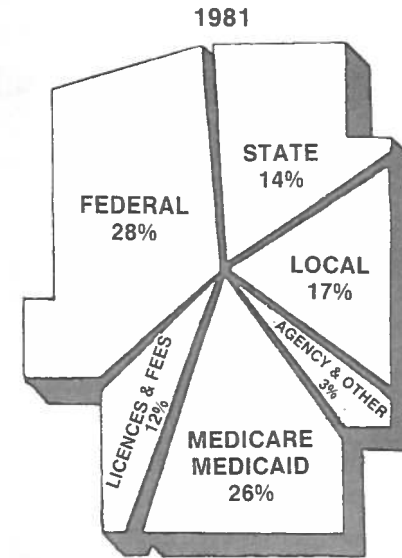

VITAL STATISTICS

The Vital Statistics division of your Health Department maintains records of the births and deaths in Tuscarawas County since 1908. The attending physician or person in attendance at the time of birth files a certificate with the local registrar for each live birth occurring in the County. The funeral director is responsible for filing a certificate for each death occurring in the County.

Certified copies of birth and death certificates are available at the state-mandated charge of \$7.00 each. Two dollars of this fee goes to the State Child Abuse Fund. You may contact the Vital Statistics Registrar during regular Health Department hours. Your Health Department issued 5,298 birth and death certificates in 1991. There were 669 births in Tuscarawas County.

Nutrition Services

The Nutrition Staff provides instruction and consultation to a varied clientele. All persons referred by the clinic Family Practice Physicians, Nurse Practitioner and Private Physicians are given individual instruction by appointment. All clinic prenatals are instructed individually and in groups.

Consultation is provided to the Tuscarawas County Jail and Headstart food services; plus the Family Planning program, Alcohol and Addiction Center, Community Health Service, School Health Nursing, Hospice, Harbor House, and the Carroll County CFHS Program.

Public speaking engagements and media presentations are available.

W.I.C.

The Women, Infants and Children's Program; a special health program funded by the U.S.D.A. and administered by the Ohio Department of Health and Tuscarawas County General Health District, helps correct nutrition related health problems pertaining to mothers and their children by providing nutritional assessments, supplemental foods and nutrition information.

Women must be pregnant, less than six months post-partum, or breastfeeding an infant less than one year old to be eligible. Children must be less than five years old. Eligibility is also based on medical/nutritional evaluation, economic need and area of residence.

Staff members are active on Advisory Boards for Headstart, F.A.M.E., Coop. Ext. They participate in community and health awareness promotions. The Licensed Dietitians are active in
