Bureau of Environmental Health Services Overview

Environmental health is the branch of public health that focuses on the relationships between people and their environment; promotes human health and well-being; and fosters healthy and safe communities. Environmental health is a key part of any comprehensive public health system. The field works to advance policies and programs to reduce chemical and other environmental exposures in air, water, soil and food to protect people and provide communities with healthier environments.

The Tuscarawas County Health Department (TCHD) Bureau of Environmental Health Services promotes public health by conducting environmental health inspections and related activities for settings such as restaurants and other food establishments, campgrounds and RV parks, public pools and spas, drinking water, septic systems, tattoo and body piercing establishments and solid waste facilities. The Bureau enforces the Ohio Revised Code, Ohio Administrative Code, and internal TCHD Codes. Staff conducts inspections, documents deficiencies and violations, recommends improvements or mandates corrections, and reviews and approves operation designs. Staff also conducts investigations related to complaints and outbreaks and responds to public health nuisances, hazards, and emergencies.

Animal Bite and Rabies Prevention Program

Rabies is a preventable viral disease that attacks the central nervous system and typically leads to death. The disease is transmitted from the infected mammal to humans and other mammals. Staff investigates all reported mammal bites and exposures to prevent the spread of disease to humans. In addition, staff prepares and ships suspected rabid specimens to the State laboratory for testing.

OAC 3701-3-28: (A) Whenever an individual is bitten by a dog or other non-human mammal, report of such bite shall be made within twenty-four hours to the health commissioner of the district in which such bite occurred. The report herein required shall be made by any health care provider, or by any licensed Doctor of Veterinary Medicine with knowledge of the bite, or by the individual bitten.

(B) Local health districts are required to submit information regarding non-human mammalian bites occurring in their district to the Ohio department of health annually. This report for non-human mammalian bites occurring in the previous calendar year shall be submitted by March first.

The Tuscarawas County Health Department partners with the United States Department of Agriculture, Wildlife Services, and the Ohio Department of Health in collecting animals for rabies surveillance. Species of concern in Tuscarawas County include raccoons, skunks, foxes, coyotes, and bats.

Wildlife Services will test other species as long as the animal is not exposed to people or domestic animals (pets and livestock). However, human and pet exposures are tested by the Ohio Department of Health.

Camps, RV, and Recreational Parks Program

The goal of this program is to reduce the potential risk for the spread of communicable disease(s), as well as injuries, and assure that parks and camps are maintained in compliance with laws and rules, specifically ORC 3729 and OAC 3701-26, through appropriate inspections.

Food Safety Program

The Food Safety Program is primarily responsible for protecting the community against foodborne illnesses resulting from health code violations and improper handling of food. It is responsible for inspections of food service operations, temporary food service operations, food vending machines, micro-markets, mobile food operations, and retail food establishments. Inspection frequency and license fees are based on the Risk Level Classification.

Things We Do:

- License and inspect all food service operations and retail food establishments
- > Temporary food service operations and retail food establishments
- Approve plans for all new and renovated food-related facilities
- > Investigate foodborne illness and reports of contaminated food
- > Investigate customer complaints
- ➤ Investigate reports of food-related violations
- > Inspect vending machines that dispense food products

Types of Licenses We Issue:

- ➤ Food Service License: Issued to a location or area where food is prepared and served in individual portions. Examples include restaurants, cafeterias, and schools
- ➤ Retail Food Establishment License: Issued to a facility that sells prepackaged food items or sells multiple servings of food products. Examples include grocery stores, gas stations, and most pizza shops
- > Temporary Food License: Issued to a facility that is operated at an event for no more than five consecutive days
- ➤ Mobile Food License: Issued to a moveable structure which must change locations at least once every 40 (forty) days
- ➤ Vending Machine License: Issued to those who sell food that requires temperature control (frozen, refrigerated, or hot food). A license is also required if the food is dispensed in an open container or cup, such as coffee, soda, soup, or hot chocolate.

Mosquito Control Program

The Tuscarawas County Health Department's immediate priority is to prepare for, and take preventive measures, to reduce the potential of the West Nile Virus (WNV) and other mosquito-borne diseases. The Department emphasizes a coordinated Integrated Pest Management (IPM) approach to minimize the public health threat from mosquito-borne diseases, by utilizing proven sound mosquito control techniques recommended by the Centers of Disease Control and Prevention (CDC). IPM utilizes a variety of control techniques and evaluation procedures that include:

- > Public education;
- Personal responsibility;
- > Source reduction;
- Surveillance and monitoring; and
- ➤ Chemical control (larvicide and adulticide).

The prevention of any mosquito-borne disease is most efficiently accomplished by the residents knowing how to recognize potential mosquito breeding sites on their property and taking appropriate actions to eliminate these breeding sites.

Nuisance Complaint Program

Per Ohio Revised Code 3707.01 and 3735, the Tuscarawas County Health Department is responsible for investigating and abating any public health nuisances in Tuscarawas County outside the city limits of New Philadelphia. TCHD receives many calls from concerned citizens about suspected nuisances which can include sewage, food, solid waste, tires, rodents, animal manure, and insects.

Public Pools and Spas Program

Inspected to minimize safety hazards, reduce potential risk for disease transmission, and assure that waters are in compliance with ordinances as outlined in Chapter 3749 of the Ohio Revised Code and Chapter 3701-31 of the Ohio Administrative Code.

Solid Waste Program


Under the authority of the Ohio Administrative Code 3745, the Tuscarawas County Health Department Solid Waste Program regulates the transportation, collection, storage and disposal of solid wastes, construction, and demolition debris in order to protect public health, welfare, and to prevent unsanitary conditions and nuisances.

Tattoo and Body Piercing Program

Germs can easily be spread from person to person, especially when you are getting a tattoo or piercing. The Body Art Program inspects and licenses body art facilities in Tuscarawas County and regulates the operations of the body artists in order to protect their customers and the general public, according to Chapter 3701-9 of the Ohio Administrative Code. The program also assists new business owners in planning their body art operation to ensure that they meet necessary standards.


Water safety program (Well and Septic)

The Health Department collects samples and conducts inspection of private well systems. Additionally, the Department approves well drilling permits and conducts completed well inspections. Permits are required before installing a new on-site sewage system on all private properties. In addition, permits must be obtained to repair, modify, or abandoned the system. Staff reviews designs, inspects, and permits new and replacement systems. In addition, the staff investigates and enforces code requirements when nuisance complaints are reported regard to failing systems. The goal of the program is to prevent disease caused by raw sewage contaminating the environment we live in and the water we drink.





2023 Environmental Health Services Program Revenue




