CARSEATS

- Abigale and Abbie distributed 12 convertibles and 2 high back booster seats in January.
- Abigale and Abbie provided 6 car seat checks in January.
- On 1/17/23 TCHD had their annual site visit for Ohio Buckles Buckeyes with Occupancy Protection Regional Coordinator Nicole Dorsey.

CRIBS FOR KIDS

- Abigale and Abbie completed safe sleep education with three (3) families and distributed three (3) cribettes to families with no other safe sleep options in the home in January.

EMERGENCY PREPAREDNESS

- Natasha and Emma attended the monthly NECO region PHEP Coordinators call on January 10th.
- The annual PHEP exercise was held on January 9th at TCHD and this year stakeholders participated in a tabletop exercise in radiological response. There were 26 participants in attendance.
- On January 9th, Natasha and Katie met with Carroll County to discuss a contract for PHEP
- PHEP Deliverables 5.2 (Outbreak Report) and 14.3 (Communications) were submitted for ODH review and approval. Deliverable 5.2 was approved on 1/13/23 and deliverable 14.3 was approved on 1/17/23.
- Katelyn and Abbie completed and passed FEMA's ICS 300 training.

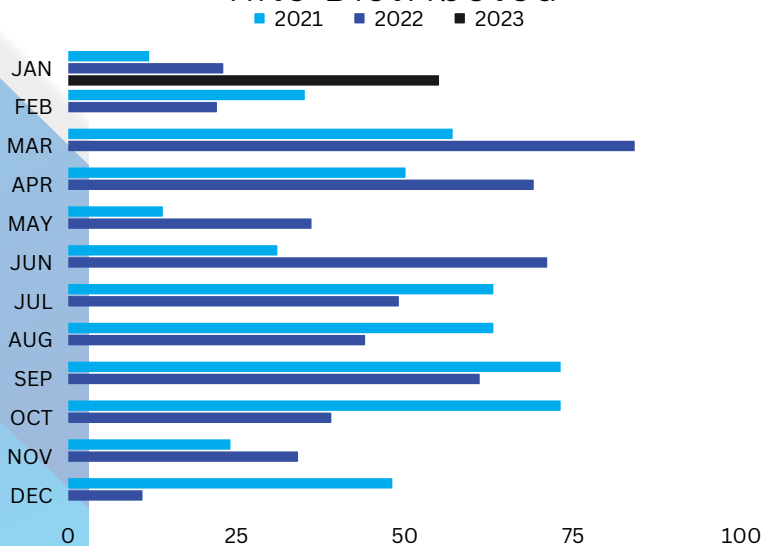
GENERAL HEALTH EDUCATION

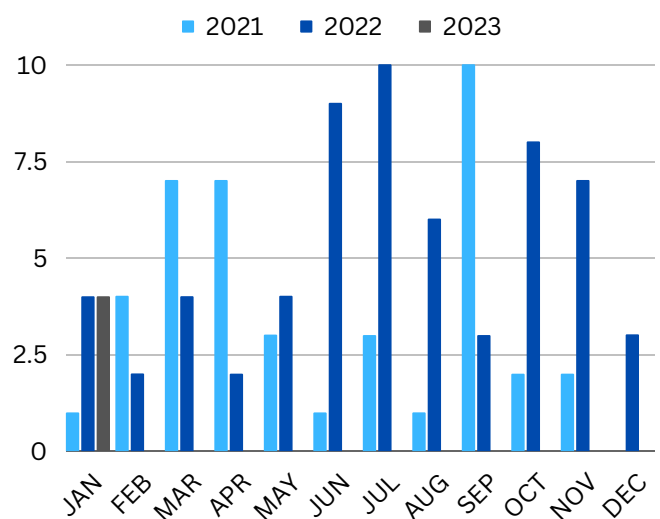
PROJECT DAWN

- During January 2023, TCHD distributed 55 Naloxone kits, trained 58 people, and had 4 known reversals.
- There were 30 First Responder Naloxone kits distributed to the following entities: Muskingum Watershed Conservancy District Rangers.
- Natasha and Lakyn attended the Addiction Task Force meeting on January 26th held at the New Philadelphia Fire Department.
- Lakyn presented the Project DAWN training at Vertava Health on January 9th and to the Bridges to Wellness Community Health Workers on January 10th.

SAFE BEGINNINGS

- Abbie served three (3) families during the month of January. Equipment distributed consisted of two (2) cribs, two (2) mattresses, three (3) baby monitors, four (4) baby gates, two (2) child proofing kits, and three (3) smoke/carbon dioxide alarms with a total value of \$938.87.

SAFE COMMUNITIES

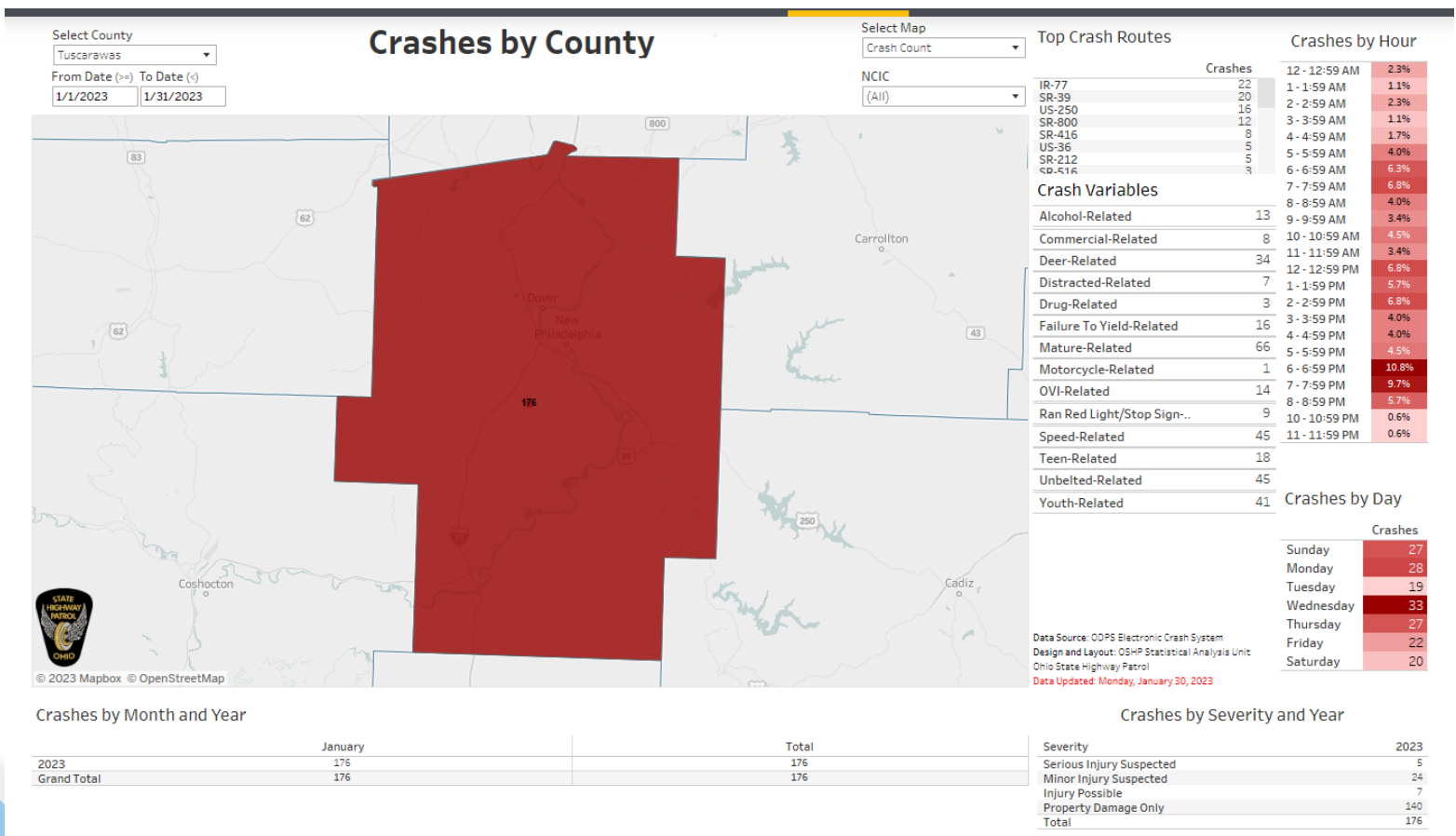
- 244 Drive Sober or Get Pulled Over magnets were distributed to Buckeye Career Center students in January.
- On January 11 there was a Teen Roadeo planning meeting held. A date has been selected for the Teen Roadeo- April 13. Packets have been distributed to the schools.
- On January 30th the 2022 Traffic Fatality Report was released to the media.

TOBACCO

- TCHD has continued to work with Leadership Tusc and the Newcomerstown High School Teen Leadership class. Newcomerstown High School is planning a "Dude, Save Your Lungs" spirit week to educate peers on the dangers of vaping and a local community event.
- Katelyn and Lakyn attended required tobacco grant meetings on January 10th and 17th.
- The Tobacco staff hosted the monthly Tobacco - Vaping Subcommittee meeting where members reviewed the Leadership Tusc Project and learned about the ODH Cessation social media campaign.
- The Tobacco grant continuation application was released on January 12

TRAFFIC SAFETY

- In 2022 in Tuscarawas County there was a total of 2,410 crashes investigated by the Ohio State Highway Patrol.
- In 2022 in Tuscarawas County there were 10 fatal crashes with 11 crash fatalities.
- The highest crash routes in Tuscarawas County in 2022 were State Route 39, Interstate 77, US Route 250, State Route 416, and State Route 800.
- The image below illustrates all crashes in January 2023 in Tuscarawas County.
- In January, there were a total of 176 accidents, one of which was fatal.



ACCREDITATION

- On January 31st, TCHD gained access to the 4th annual report for the accreditation cycle. TCHD has the option to complete a Reaccreditation Readiness assessment in this annual report.
- Natasha has provided directors with a guideline of how many documents should be completed each month to keep on the timeframe for completion for reaccreditation.
- TCHD will reapply for accreditation (reaccreditation) in the first quarter of 2024.
