- Emma attended an Orientation for Ohio Accreditation Coordinators webinar on 11/30.

### CARSEATS

- Abbie distributed 6 convertibles and 3 high back boosters in November.
- Abbie completed one car seat check at TCHD in November.

# **CRIBS FOR KIDS**

- Abigale and Abbie provided safe sleep education and cribettes to seven families throughout the month of October.
- TCHD received 10 cribettes in September from ODH and Stark County Health Department.

# **DIAPER BANK**

- In November, 13 new families were served from the diapers from the Heart of Ohio Diaper Bank. 20 families returned from previous months to receive services.
- In November, 1,798 items from the diaper bank were provided. This includes diapers, pull-ups, wipes, and period packs.

### **EMERGENCY PREPAREDNESS**

- Emma attended ICS-400 course that took place at the Stark County EMA on 11/1 and 11/2.
- Natasha and Emma attended the weekly ODH Epi calls throughout the month of November.
- Received Board approval on many PHEP plans updates that had been done throughout the year during the November meeting.
- Emma attended a PHEP 101 Training series that took place on 11/13.
- On 11/30 Emma virtually attended the monthly PHEP meeting with the NECO region.

# **GENERAL HEALTH EDUCATION**

- Shannon Fox started on November 27 as the newest Public Health Educator II who will be focusing on the tobacco use prevention and cessation grant.
- Natasha, Angie, and Alexa completed seven interviews for the Epidemiologist position.
  - The intent is to have one hired to start off 2024.

# **INJURY PREVENTION - CHILD**

- Abigale facilitated the first Occupant Protection Subcommittee meeting on 12/5 in coordination with Promedica.
- Abigale secured two new partnership agreements, one with Strasburg (signed 11/28) to complete the Safe Routes to School Curriculum and the second with the Tuscarawas County Department of Job and Family Services to complete a parenting course in coordination with JFS.
- Abigale also secured a partnership agreement with Claymont to successfully complete the Graduated Driver Licensing (GDL) program required through the grant.


# **INJURY PREVENTION - ADULT FALLS**

- Emma and Lakyn facilitated Bingocize sessions at the Tuscarawas County Senior Center on Tuesdays and Thursdays.
- A letter of commitment was signed from the Tuscarawas County Sheriff's Office to provide data on 911 calls related to falls in Tuscarawas County.
- TCHD started receiving 911 falls call data in November.
- Abbie and Katelyn had a meeting with Peggy from Harcatusc's RSVP program about a potential partnership for falls grant initiatives.
- Katelyn and Natasha had a meeting with the Area Agency on Aging about them joining the coalition and providing support for grant initiatives.

#### **PROJECT DAWN**

- During November 2023, TCHD distributed 58 Naloxone kits, trained 57 individuals, and had 0 known reversals.
- Lakyn facilitated a naloxone training for The Bluffs on November 13th.
- Lakyn facilitated a naloxone training for the Ross School of Nursing students on November 20th.
- Lakyn facilitated naloxone distribution to interested community members at the New Towne Mall Holiday Market.
- There were 6 first responder naloxone kits distributed to the Cleveland Clinic Union Police Department.

#### SAFE BEGINNINGS

- Abigale and Abbie provided education and served 11 clients Safe Beginnings equipment in November totaling \$2,866.81. Items included: cribs, mattresses, baby video monitors, baby gates, child proofing kits, fire extinguishers, and more.
- On November 14th, Abbie attended story time at the New Philadelphia Library to speak about the Safe Beginnings programming and the importance of child proofing.

#### TOBACCO

- Katelyn attended ODH's webinar on the new requirements for tobacco-free schools in 2024. This information and webinar were distributed to all school districts in Tuscarawas County by the ESC.
- Katelyn trained Youth 2 Youth groups at Claymont, Strasburg, and Tuscarawas Central Catholic High Schools on the Anti-Vaping Video Contest.
- Katelyn and Lakyn hosted the Empower Tusc Tobacco & Vaping Committee Meeting. They completed the review of the strategic plan with members.
- Tobacco Retailer Compliance Checks are being planned with help from the Tuscarawas County Sheriff's Offic

# **TRAFFIC SAFETY**

- In November, there were a total of 247 accidents.
- In November, the most crashes occur during the 6-6:59am hour and the most crashes occur on Thursdays.
- As of November 30th, there have been two (2) fatal crashes in Tuscarawas County in 2023.
