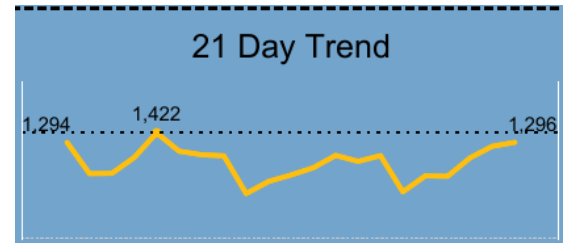

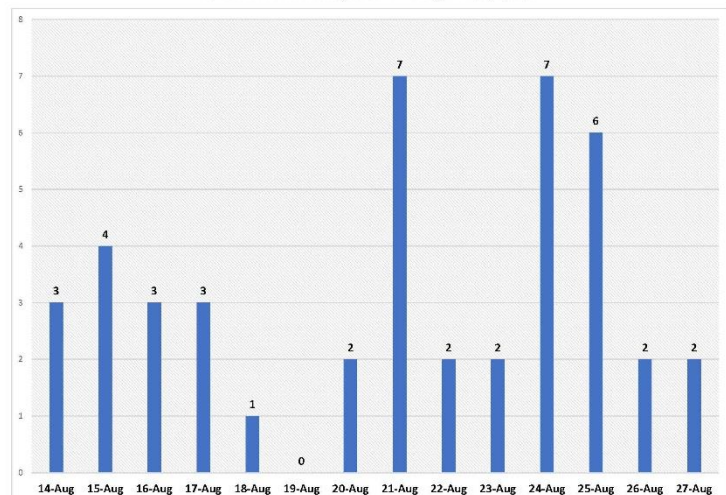

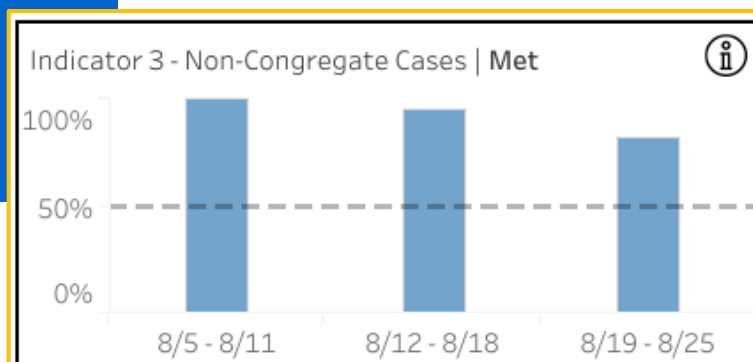
## LEVEL 1

(as of 8/27/2020)

This is the fourth week since the Ohio Public Health Advisory System was initiated that Tuscarawas County has been designated as a Risk Level 1 County. To be classified a Risk Level 1, 0 to 1 of the 7 indicators must be met. Tuscarawas County meets the indicator circled below:

<b>1.</b> 50 cases/ 100,000 Most Recent 2-weeks	<b>2.</b> New Cases Trajectory increase over a 5 day period	<b>3.</b> Proportion in Non- Congregate Settings (LTC)	<b>4.</b> COVID-like ED Trajectory increase over a 5 day period	<b>5.</b> COVID-like OP Trajectory increase over a 5 day period	<b>6.</b> Hospitalization Trajectory increase over a 5 day period	<b>7.</b> >80% threshold for capacity + 20% COVID ICU
